3. The Engineer for EUA will prepare an Opinion of Probable Cost. If the Opinion of Probable Cost is approved by Owner/Developer, a cash deposit representing 80% of the preliminary engineering fee shall be paid to the Association.

- 4. The EUA Engineer will prepare construction plans and contract documents. The Eudora Utilities Association will receive proposals from approved contractors for construction.
- 5. Eudora Utilities Association, Inc. will contract with a responsible contractor for construction of the water system improvements in accordance with Contract Documents for the EUA.
- 6. All connections to the existing water system shall be made as per the Eudora Utilities Association Inc.'s / EUA Engineer's instructions, including meter taps on existing water lines.
- 7. All easements required must be secured by and at the expense of the Owner/Developer.
- 8. The EUA will supply and maintain the water meters.
- 9. Prior to connecting individual houses, each individual resident owner must pay a non-refundable connection fee and deposit as a guarantee of payment of monthly water bills. The deposit will be refunded to the homeowner when service is terminated and all fees, bills and costs due have been paid.
- 10. All water services are subject to the tariff and service rules and regulations of the EUA as the same may be amended and changed from time to time.
